AIA | WA Welcomes New Executive Director

Tammie Sueirro is AIA|WA's new Executive Director, replacing Jeffrey Hamlett, Esq., AIA after five years of service to the Council.

Tammie holds a Bachelors from Architecture California Polytechnic State University, San Luis Obispo. She was a principal at Mithun as well as the director of human resources and project director for Mission Driven Housing. In this role, she directed large-scale affordable housing projects, integrating a variety of innovative community engagement processes and building systems. She received a Certificate of Nonprofit Management from the University of Washington in 2011. Tammie was the Executive Director of Zeno, where she worked with low-income elementary school



communities to develop a positive culture around mathematics, and most recently she was the Chief Administrative Officer for Plymouth Housing, which provides permanent supportive housing to homeless adults in Seattle. She has served on several boards, including chair of the board of Hospitality House Women's Shelter in Burien and treasurer of the American Institute of Architects-Seattle.

Bothell Deputy Mayor Davina Duerr was appointed to serve in the State House



Duerr has a bachelor's degree in architecture from Syracuse University and is a senior interior architect at Ware Malcomb in Bellevue. She has served on the Bothell City Council since 2016. Duerr will hold the House seat through the 2020 election and will likely run for reelection then. The publication Washington State Wire published a Q&A with Rep. Duerr in which, she talks about the value architects bring to public policy:

> I am an architect by education and career. And I would say that definitely plays into my qualifications because architects are problemsolvers. Every design project is a puzzle to solve and I think that is very similar to the role of a legislator. You see problems and you try to fix them.



House Dems to **Choose New** Speaker

House Democrats will meet this week to select their new leader and the presumptive Speaker of the House. This follows Frank Chopp's announcement last year that he would leave his leadership post after the 2019 session.

While a number of candidates expressed interest in the position after Chopp's announcement, the race appears to be coming down to two choices: Rep. June Robinson (Everett) and Rep. Monica Stonier (Vancouver). Whoever it is, it will be notable that the person selected will be the first female speaker in Washington's history and that both the House and Senate Democratic leaders will hail from outside Seattle.





Residential Architect Sought to Serve on State Building Code Council's Building Code Technical Advisory Group

AIA|WA is seeking an architect willing to serve on the SBCC's Building Code Technical Advisory Group (TAG), which makes recommendations to the Council on the International Building Code and the International Existing Building Code. The TAG has an open seat in the category of Home Designer, so we are looking for someone who primarily works on residential projects. The TAG reviews new model codes against the previous version, assesses statewide amendment proposals and makes recommendations for the SBCC's consideration. AIA National Issues Report on Building Codes + Climate

AIA National's Blue Ribbon Panel for Codes and Standards issued a report outlining AIA's vision for the adoption and application of building codes and standards as design tools in a resource-constrained future. The publication, Disruption, Evolution and Change: AIA's Vision for the Future of Design and Construction, details an aspirational path forward for the profession's commitment to meeting 2030 climate objectives. The four focus areas of the report—energy, health/safety, welfare and transparency—help to frame discussions and partnerships to advance environmentally responsible design and construction. As part of the report, AIA National issued the following statement of values related to building codes and climate change:



AIA's vision for the future of design and construction

WHERE ARCHITECTS STAND: A STATEMENT OF OUR VALUES

We stand for protecting communities from the impact of climate change. Global warming and man-made hazards pose an increasing threat to the safety of the public and the vitality of our nation. Rising sea levels and devastating natural disasters result in unacceptable losses of life and property. Resilient and adaptable buildings are a community's first line of defense against disasters and changing conditions of life and property. That is why we advocate for robust building codes and policies that make our communities more resilient.

Dept. of Commerce Schedules 100% Clean Electricity Implementation Workshops



The Washington Department of Commerce will hold two public workshops to discuss implementation of Washington's new 100% clean electricity law, known as the Clean Energy Transformation Act. Input from these workshops will help the agency set priorities for rulemaking work over the next two years.

State Building Code Council Reviews 2018 Energy Code Amendments

2018 Commercial Energy Code Amendments Approved

On July 26, the State Building Code Council approved a list of amendments to the 2018 Commercial Energy Code that will take effect on July 1, 2020. On the whole, the amendments will strengthen the code, providing additional energy efficiencies, and respond to mandates by the Governor and the Legislature requiring a more efficient code with each revision cycle.

2018 Residential Energy Code Amendments Under Review

The State Building Code Council is currently undergoing a review process for proposed amendments to the state's 2018 residential energy code. Twenty-four proposals have been accepted by both the Council's Energy Code Technical Advisory Group and the full Council to be moved forward to public comment.

The proposed residential energy code amendments are open for public comment through Sept. 27, 2019. The SBCC will also take public comments in person at hearings in Spokane (Sept. 13) and Olympia (Sept. 27). The effective date for the 2018 code amendments will be July 1, 2020.

Commenting on the proposals

AIA Washington Council will submit comments on the proposed amendments provided that enough consensus exists among members. While members are encouraged to offer comments directly to the SBCC, we welcome your feedback on any of the proposals and will incorporate it into our comment considerations. You are welcome to offer comments on as few or as many of the proposals as you wish. More details, and info about each proposal, is available here.
