Former Executive Director Jeffrey Hamlett Receives Jennie Sue Brown Award

Jeffrey Hamlett, Esq., AIA, and former Executive Director of AIA|WA, was awarded the Council's highest member honor, the Jennie Sue Brown Award, at AIA|WA's Advocacy Summit on Oct. 24.

The award honors the legacy of Jennie Sue Brown, FAIA, and recognizes effective engagement in advocacy to advance the practice of architecture and the lifetime achievements of members who have: made a significant statewide contribution; served the profession through increasing public awareness, political action, or government involvement; and continually enhanced the practice of architecture.

Over many years of service to AIA|WA, Jeffrey served as a member of the Board, as AIA|WA's representative to the Architects and Engineers Legislative Council, as President of the Council, and finally as Executive Director from 2014-2019. Jeffrey provided strong executive leadership to the Board in guiding AIA|WA at a critical point in the organization's history, and under his leadership the Council survived its challenges and became a stronger, more effective organization.



With the Board of Directors, Jeffrev recrafted the vision mission and of AIAIWA to focus on its core role of statewide legislative advocacy; led the effort to reorganize AIA|WA's leadership structure and operations as а means to improve

efficiency, accountability, and equitable representation of local components in Council operations and activities; and facilitated the move of AIA|WA's offices from Olympia to Seattle as a means to better utilize the resources of AIA Seattle and to locate the office nearer to the majority of members. Jeffrey was also instrumental in the revision of Washington's Architects Practice Act in 2010 and again in 2019.

Jeffrey will continue to serve the Institute and the profession in his newly-elected role as Regional Director and Strategic Council Representative for the AIA Northwest and Pacific Region.

Congratulations Jeffrey and thank you for your years of service to the profession in Washington.

Advocacy Summit Sets Agenda for 2020 Legislative Session

AIA|WA held its annual Advocacy Summit on Oct. 24 in Seattle, where members met in policy committees to review the chapter's goals for the 2020 legislative session and identify emerging issues. Here's a high-level look at what they decided:

PRACTICE ISSUES

Condos/HOAs

- Support the Washington State Community Association Institute's amendments to the Washington Uniform Common Interest Ownership Act (which governs condo and HOA law) to simplify owner opt-in procedures and modernize prior statutes. *Read a full description here.*
- Oppose proposals for technical changes to WUCOIA that reduce or eliminate requirements for reserve studies.

Contracting

 Oppose legislation to require state contracts to undergo a review to determine if the work can be brought in-house (HB 1521), unless A&E is fully exempted.

TAXES, EDUCATION + CAPITAL BUDGET

<u>Tax</u>

- Monitor efforts to address missing revenues from 2019's B&O tax adjustments (the state is getting less revenue than expected due to poor bill drafting).
- Monitor legislation to impose a capital gains tax AIA|WA supports a tax in theory but much depends on the details, especially which current taxes are offset, if any.





- Oppose legislation to require computer verification software for state contractors (HB 1744).
- Oppose legislation to require the naming of WSDOT project subcontractors (HB 1321).
- Oppose legislation to require bid documents for public works projects over \$1 million to include the names of all subcontractors (SB 5457).

Codes

- Oppose legislation to lengthen the building code cycle (SB 5634).
- Support legislation to address seismic risk reduction (SB 5557 task force).

<u>School funding</u>

- Support bills to reduce the voter threshold for school construction bonds (this requires a constitutional amendment) to 55 or 50 percent from the current 60 (SJR 8201; SJR 8202).
- Support funding reform via OSPI, including funding increases for K-12 construction. Place an architect on OSPI's funding committee.
- Evaluate efforts to exempt school districts from sales and use tax on construction.
- Participate in an OSPI statewide advisory group to address school safety; include design elements in any effort to address safety in school buildings.

LIVABILITY & AFFORDABILITY

- Support potential legislation to require the inclusion of duplexes and triplexes in single family zones in certain cities. (Oregon passed similar legislation earlier this year.)
- Support legislation to require minimum density and density around public amenities in Growth Management Act (GMA) areas (SB 5769). Includes grant funding for planning.
- Support legislation to require minimum density around Sound Transit stations (SB 5424).
- Support efforts to extend HB 1923, passed in 2019 to increase residential building capacity through voluntary options provided to cities, to allow a longer period for changes to SEPA appeals and/or more mandates for options that can be undertaken by cities.
- Support legislation to add income basis and density triggers to the housing element of comprehensive plans under the GMA (SB 5440).
- Support legislation that allows local governments to preserve affordable housing through property tax exemptions (HB 1745).
- Support legislation to enact a progressive real estate excise tax (REET) to provide funding for affordable housing (HB 1921, others).
- Support a permanent funding source for the Housing Trust Fund.
- Support additional funding for growth management planning.



- Champion legislation to allow a C-PACER (Commercial Property-Assessed Clean Energy & Resilience) financing mechanism for deep climate and seismic retrofits (HB 1796).
- Shape Rep. Beth Doglio's embodied carbon legislation (no draft yet), likely to center around environmental product declarations for statefunded projects.
- Support further restrictions on HFCs in refrigerants.
- Study any cap and trade (or "cap and invest") proposals.
- Advocate for state funding to provide training for code officials.

Non-legislative

 Participate in the Dept. of Commerce's rulemaking process for HB 1257, enacted in 2019, the building performance standard for commercial buildings.

2020 Legislative Session Facts

- Washington's State Legislature meets for 60 calendar days in even years and 105 calendar days in odd years.
- The 2020 session begins on January 13.
- All bills from the 2019 session which did not pass are alive for the 2020 session and revert to the highest committee they achieved in their house of origin. New bills may also be introduced.
- The state's three budgets are determined in odd years, with adjustments made in even years as necessary.

AIA | WA Board votes to oppose I-976

AIA|WA's Board of Directors has endorsed the No on Initiative 976 campaign to forestall immediate cuts to dozens of vital transportation improvements statewide and avoid permanent damage to our ability to keep Washington's transportation corridors safe and effective.



From AIA|WA's I-976 statement

I-976 will significantly reduce state transportation-related revenues by capping car tab fees at \$30 per year; eliminating the 0.3% sales tax on vehicle purchases; and lowering electric vehicle and snowmobile fees. In addition, I-976 would cut Sound Transit's regional revenues by reducing the agency's motor vehicle excise tax rates and requiring the refinancing or terminating of existing Sound Transit bonds. Local governments would also be impacted; I-976 would repeal the authority of cities to generate revenues through vehicle fees used to pay for local roads, sidewalks, and more.

Many core values of the AIA—equity, environment, community, design quality, and life/safety—are affected by transportation choices and built infrastructure. Supporting mass transit projects are at the heart of AIA|WA's transportation agenda, addressing sustainability and quality of life issues while providing a range of transportation options to serve all of our state's communities.
