- Washington state residents (minimum 2 consecutive years)

- A student admitted to the undergraduate architecture program who is in the first year of study within the major at University of Washington or Washington State University.

AIAWA Board Votes to Support "No on I-2117"

In June, the AIAWA Board of Directors officially joined a coalition of over 350 organizations in Washington State, including leading companies and small businesses, environmental leaders, Tribal nations, labor unions, faith groups, transportation advocates, and community organizations, to support the "No on 2117" campaign. This initiative is critical as it seeks to repeal the Climate Commitment Act (CCA), a key law in our state's fight against climate change. Here's a brief overview of Initiative 2117, the potential impacts, and the arguments surrounding it.

What is the Climate Commitment Act (CCA)?

Enacted in May 2021, the CCA (SB 5126) is a significant climate policy designed to reduce greenhouse gas emissions through:

- Cap-and-Trade System: Requires major polluters to purchase emissions allowances, with decreasing limits over time to drive down emissions.
- Emission Reduction Targets: Aims for reductions of 45% below 1990 levels by 2030, 70% by 2040, and net-zero by 2050.
- **Revenue Generation**: Funds from emissions allowances are used to support clean energy projects, transportation improvements, and other environmental initiatives.

What Would We Lose if I-2117 Passes?

If Initiative 2117 succeeds, the repeal of the CCA would allow more pollution and strip away billions of dollars in investments in community priorities in every county in our state including:

- Loss of Environmental Protections: Cuts to funding for clean air and water programs, forest health, and wildfire prevention.
- **Increased Costs for Consumers**: Elimination of programs offering energy-efficient appliances, utility bill discounts, and no-fare transit for youth.
- Transportation Infrastructure Risks: Potential reductions in public transit, ferry services, and road maintenance, which could worsen traffic and limit accessibility.
- Impact on Tribal Nations: Loss of support for flood protection, clean energy projects, and transit services on tribal lands.
- Reduced Fish Habitat Protection: Cuts to funding for salmon recovery and fish habitat improvements.

Arguments For and Against Initiative 2117

- Supporters of I-2117 Argue:
- ⇒ **Cost Concerns**: They believe the CCA has led to higher costs for fuel, food, and energy without sufficient environmental benefits.
- ⇒ **Alternative Approaches**: Repealing the CCA would allow for other strategies to reduce emissions without imposing financial burdens on consumers.
- Critics of I-2117 Argue:
- ⇒ **Loss of Climate Progress**: The CCA is crucial for reducing emissions and tackling climate change, setting important pollution reduction standards.
- ⇒ **Impact on Revenue**: Funds from the CCA are vital for environmental projects, transportation, and community support, which would be at risk if the initiative passes.

Why AIAWA Supports "No on 2117"

By joining this broad coalition, the AIAWA Board stands firm in our belief that repealing the CCA would undermine Washington State's climate goals and disrupt essential investments in environmental and community programs. Supporting the "No on 2117" campaign is a commitment to continue advancing toward a sustainable future.

Interim Activities

Kit Kollmeyer to Represent AIAWA on SHB 2071 Advisory Group Standard Plans

The 2024 legislature enacted SHB 2071, which introduces an optional standard energy code plan set (Standard Plans) designed to meet or exceed all residential energy code regulations under the International Residential Code. AIAWA has been actively involved in shaping this initiative and has a seat on the advisory group guiding the project. This group, comprised of experts from design, construction, and development, will support the Office of Regulatory Innovation and Assistance (ORIA) and the WSU Energy Program in ensuring the plan set meets its objectives.

We are pleased to announce that Kit Kollmeyer, from Twisp, WA and owner of Serious Fun Studio, will represent AIAWA on this advisory group. Kit brings valuable experience with the IRC and a deep understanding of both western and eastern Washington.

We will keep our members updated on any developments as the project progresses.

AIAWA Efforts Result in Key Wins on State Fee Schedule and Public Project Guidelines

We are pleased to announce that our collective advocacy efforts have led to a significant win for AIAWA members. On May 15, AIAWA submitted a letter to the Office of Financial Management (OFM) with recommendations regarding the proposed changes to the state fee schedule and guidelines for public projects.

In response, OFM informed us that, based on the comments received, they have decided to remove the new basic services for the 2025-27 biennium. The basic services will remain as they are in the current guidelines. Furthermore, OFM has committed to engaging in a consultative process with stakeholders, including state agencies and the construction community, to review the rates and services for the 2027-29 biennium.

Additionally, the proposed 2025-27 maximum negotiated hourly billing rates and the updated Building Cost Index (BCI) ratio, as recommended by AIAWA, have been adopted.

We extend our huge thanks to our Practice Committee members, advocacy team, and all members who contributed by sending letters urging OFM to reconsider their changes. This outcome is a major victory that protects the livelihood of our members working in the public sector and those involved in projects using these contracting tools.
