Deeper Dive into AlA's Issue "Buckets"

With this year's legislative session complete, we'll be taking a deeper dive into the issues AIA responds to, reviewing one of our issue "buckets" each month. This is a great time to offer feedback on AIA's agenda and identify new issues for our Board to consider.

This month's newsletter covers issues related to the Practice of Architecture.

Practice issues are AIA's top priority in the Legislature and within state regulatory agencies. This bucket includes any issue that impacts individual architects, designers, or associates; firms; contracts; building types; project delivery; and more.

In this issue we review the major practice issues that AIA has worked on in recent years. We welcome your feedback on these issues and others that are important to you.



AIA|WA Committees

The core of AIA Washington Council's advocacy work is conducted by its policy committees. Within the committee structure, issues are brought to the Council's attention, debated and referred to the Board for executive action. If you'd like to be involved in advocating for the architecture profession, the committees are where you get started.

AIA members may join one or more committees at any time, or just ask to be put on the email list. Some committees meet monthly and others on an as-needed basis.

Practice Issues

Below are many of the practice-related issues that AIA has worked on at the state level in recent years.

Architects Practice Act: AlA's top priority is to protect the integrity of the Architects Practice Act and the role of architects and architecture in the state. Changes to the statutes that comprise the Act are generally requested by AlA. We try to limit the number of times we "open up the Act," because once these statutes are open and before the Legislature, non-architects have an opportunity to request modifications.

The last major update to the Architects Practice Act was passed in 2010. In 2019 AIA made slight revisions to the Act to update the licensing requirements to match the national NCARB standard.

Licensing: As noted above, AIA successfully supported legislation to conform Washington's licensing requirements with NCARB's national standard in 2019. We have opposed bills that allow the legislature to make determinations about licensing requirements without approval of the Board for Architects, including bills that provide more rapid licensing for individuals entering Washington with a license from another state. AIA did support a bill that passed this year to allow individuals with felony convictions who have completed their post-sentence requirements to petition a licensing board to be allowed to apply for a license

Employment: AIA generally does not get involved in employment legislation, but we have opposed a "qui tam" bill that would allow private, solicited lawsuits against employers on behalf of employees on labor and employment laws. We monitor bills related to workers' compensation and other labor-related requirements.





Condo Liability: AIA supports efforts to reduce liability insurance rates for designers on condo projects. A major condo liability reform bill passed in 2019, with some minor bills aimed at decreasing building envelope review and HOA meeting notice requirements passing this year. We expect the Legislature's legal committees to continue to look at more ways to expedite condo projects, an important housing opportunity that was hampered for many years by Washington's previous Condo Act.

Contracting: AIA weighs in on a wide range of contracting issues that impact architectural projects, including:

- Alternative project delivery
- Predesign requirements
- Issues related to the Minority and Women-owned Business Enterprises program
- Bidding requirements
- Issues related to local government plan review
- Issues related to competitive public works contracts
- Contractor liability related to subcontractors
- Efforts to include proof of work requirements on state contracts to verify hours worked
- Bid limits
- Small works roster issues
- and more

Often, we work with the American Council of Engineering Companies and the Associated General Contractors to coordinate a building industry position on these issues.

Washington's NCARB AXP Coordinators

The NCARB Architectural Experience Program (AXP), formerly known as IDP, is a mandatory requirement in our state for the Architect Registration Exam (ARE). Washington has two AXP coordinators who you can contact if you have questions about the program. Drew Kleman AIA and Erica Loynd FAIA are appointed by the AIA and are a resource for the profession.
