AIA Gears Up for Glasgow: COP26

In November, AIA National will participate in the U.N. Climate Change Conference (COP26) in Glasgow, Scotland, which will convene nations from around the world for climate negotiations. Following are excerpts of a letter from 2021 AIA President Peter Exley FAIA to Congress and an op-ed by Exley and 2021 AIA Gold Medalist Ed Mazria FAIA published in *The Hill*—both calling for the urgent need for climate action.

From Peter Exley FAIA

Dear Members of Congress
and Climate Staff Members:

I am writing to you, as the President of the American Institute of Architects, to reassert AIA's commitment to the protection of the health, safety, and welfare of the public. Since 1857, this concern is central to all that we, as architects, do.

AIA's over 94,000 members have worked to advance our nation's quality of life through design. From designing the next generation of energy-saving buildings to making our communities healthier and safer, architects play a central role in influencing and improving the built environment through their work. Climate change has certainly challenged all of us in terms of creating both greater mitigation (reducing climate change altogether) remedies and adaptation methods (adapting to the climate change already in the pipeline).



I write today to urge Congress to work with the architectural community to take bold steps to achieve true climate action. The upcoming U.N. Climate Change Conference (COP26) in Glasgow offers us an opportunity to double down to target the solutions we need.

First, AIA believes we must address two long-overdue vulnerabilities in the built environment: building emissions and building resilience. Taken together, these challenges are not only contributing to accelerated climate change, but also worsen the impacts of climate change on building occupants. AIA urges Congress to include investment in buildings in the infrastructure package and to work with AIA and others to meet the commitments made by the U.S. during the upcoming COP26 in Glasgow.

On climate change, it's time to lead

Devastating wildfires and brutal heat waves. Expanding drought. Disastrous storms and deadly flooding. Billions of dollars of damage and heartbreaking stories of lost lives and destroyed businesses and homes. Climate change is upon us, and the impacts we are witnessing and experiencing this year are but a harbinger of what's to come in the years ahead if we collectively fail to act.

Despite the very real and present impacts of climate change, far too many world leaders continue to effectively sit on the sidelines. Collectively, at a moment when bold action is needed, global leaders have yet to mount a response commensurate with the challenge even as the window for action closes.

Buildings are the largest source of the world's carbon emissions globally, accounting for approximately 40 percent of total emissions due to the energy used for heating, cooling, lighting, appliances, and building construction. When you add the embodied carbon of building interiors, systems, and associated infrastructure, that percentage is substantially higher. The building industry has a critical role to play in solving the climate crisis, and fortunately for all of us, they are leading the way. For example, today, the entire U.S. building sector's CO₂ emissions are 30 percent below 2005 levels even though over 50 billion square feet was added to its building stock over that same period.

And now, more than 60 of the largest and most influential international architecture, landscape architecture, engineering, planning and construction firms, collectively responsible for over \$300 billion in annual construction, along with two dozen organizations that represent more than one million building industry professionals worldwide, announced a shared commitment to dramatically reduce carbon emissions, and they have challenged sovereign governments to do the same.

The firms and organizations are signatories to the 1.5°C COP26 Communiqué—an open letter to sovereign governments calling on them to commit to reducing carbon emissions to meet the Paris Agreement's 1.5°C carbon budget—which scientists have determined is necessary for a good probability to avoid the worst impacts of climate change—a 50 percent to 65 percent reduction by 2030 and fully decarbonize all sectors by 2040.

AIA National Small Project Awards

AIA National's Small Project Design Knowledge Community seeks projects for its Small Project Award Program—aimed at raising public awareness of the value and design excellence that architects provide regardless of the limits of size and budget. Categories include:

- Small project construction, object, work of environmental art or architectural design element up to \$250,000 in construction cost
- Small project construction up to \$2.5 million in construction cost
- Small project construction, object, work of environmental art or architectural design under 5,000 SF
- Unbuilt project award: any unbuilt design that meets any of the category requirements above

All projects must demonstrate design achievement, including how the project fits into its environment and how the project connects to the Framework for Design Excellence. Submissions are due by Nov. 12. More info on submitting projects [here](#).

Historic Preservation of Diverse Places

The National Trust for Historic Preservation is launching the **Telling the Full History Preservation Fund** to help interpret and preserve historic places of importance to underrepresented communities across the country. Grant applications will be accepted from 501(c)(3) nonprofit humanities-based organizations, accredited public and 501(c)(3) colleges and universities, as well as state, local, and Tribal governmental agencies starting November 2021. Among other areas, they may be used for architectural design and planning to preserve and activate historic places of importance to underrepresented communities—including, but not limited to, women, immigrants, Asian Americans, Black Americans, Latinx Americans, Native Americans and LGBTQA communities.

Andrew Parker has been selected by AIA Spokane as its new Executive Director.



C-PACER Enacted in 3 Counties; King County's Program Underway



In 2019, AIA|WA worked with state legislators to pass **C-PACER** (Commercial Property Assessed & Clean Energy-Resilience) legislation. C-PACER is an important financial tool that can be used to decarbonize commercial, industrial, non-profit, and multifamily buildings. The program authorizes private loans which allow owners to finance projects that increase energy efficiency, water efficiency, or resiliency. Critically,

these are liens on the building and not attached to the owner. This means that the loans do not appear on the owners' books or stay with the owner when sold, allowing owners to make deep green improvements now even if they plan to sell the building in the short or medium term.

C-PACER loans will allow owners to make long-term decisions on sustainability projects that will pay for themselves over time. They will also be critical for many owners who will need to comply with the state's clean building performance standard – the Clean Buildings Act – in the coming years.

The state legislation was enabling legislation, allowing but not requiring counties to implement C-PACER programs. Each county must implement its own program via legislation. To date, **Whatcom**, **Thurston** and **Clark** counties have passed C-PACER programs. **King County's program** is currently under consideration by the King County Council. King County's draft ordinance was amended to restrict projects that use fossil fuel-fired equipment from being eligible for C-PACER loans after 2023. That language is not final, but the legislation has been moved out of committee to the full County Council.

We expect additional counties to address C-PACER legislation in 2022.


